371. DECLARATIONS OF INTEREST

There were no Declarations of Interest made in terms of the Councillors' Code of Conduct.

372. MINUTE OF PREVIOUS MEETING

The Minute of Meeting of the Aberfeldy Common Good Fund Committee of 24 February 2010 (Arts. 98-103) was submitted, approved as a correct record and authorised for signature.

373. APPLICATIONS FOR FINANCIAL ASSISTANCE

There was submitted a report by the Head of Finance (10/351) on applications received for financial assistance.

Resolved:

- a) **Aberfeldy Parish Church of Scotland**
Aberfeldy Parish Church of Scotland be awarded a grant of £160 towards the cost of the annual upkeep of the Church Clock.
- b) **Aberfeldy Festive Committee**
Aberfeldy Festive Committee be awarded a grant of £500 towards the total cost of £2,570 for the Festive Celebrations, which included a Christmas Street Market from 4 to 31 December 2010 and a public Hogmanay celebration with local bands playing.
- c) **The Breathe Project (Aberfeldy Parish Church)**
The Breathe Project (Aberfeldy Parish Church) be awarded a grant of £500 towards the total cost of £2,610 for giving up to ten young people the opportunity to attend a week long sports camp, from 18 – 23 July 2010, where they would receive professional tuition in two main sports of their choice as well as attending personal development sessions to encourage them to build on skills such as confidence, self belief, leadership and motivation.

374. FINANCIAL STATEMENT

There was submitted and noted a report by the Head of Finance (10/352) detailing the income and expenditure on the Aberfeldy Common Good Fund for the period up to 31 May 2010, anticipating the Fund would break even in financial year

375. BUDGET STATEMENT

There was submitted a report by the Head of Finance (10/353) seeking approval of the Aberfeldy Common Good Fund Budget for financial year 2010/2011.

Resolved:

The Aberfeldy Common Good Fund Budget for financial year 2010/2011 be approved, showing an anticipated break even position for the Fund in 2010/2011, and the Fund's projected Revenue Account Balance as being £87,758 at 31 March 2011.
