208. DECLARATIONS OF INTEREST

209. MINUTE OF PREVIOUS MEETING

The Minute of Meeting of the Aberfeldy Common Good Fund Committee of 17 December 2008 (Arts. 707-710/09) was submitted, approved as a correct record and authorised for signature.

210. APPLICATIONS FOR FINANCIAL ASSISTANCE

There was submitted a report by the Executive Director (Corporate Services) (09/213) on applications received for financial assistance.

Resolved:

(a) Locus Breadalbane Ltd

Locus Breadalbane Ltd be awarded a grant of £1,000 towards the cost of installing a clock in the tower in Aberfeldy.

(b) Breadalbane Cricket Club

Breadalbane Cricket Club be awarded a grant of £530 towards the cost of providing equipment for forty-one junior members for use in winter and summer coaching and junior matches throughout the following year.

(c) Move 2 Improve

Move 2 Improve be awarded a grant of £1,590 towards the cost of installation and watering of three new hanging basket trees at the entrance to Aberfeldy, this being on the East and West side of the town, as well as a static display at Appin Place.

(d) Aberfeldy Parish Church

Aberfeldy Parish Church be awarded a grant of £160 towards the cost of winding the village clock on Taybridge Road, Aberfeldy for 2009.

211. FINANCIAL STATEMENT

There was submitted and noted a report by the Executive Director (Corporate Services) (09/214) detailing the income and expenditure on the Aberfeldy Common Good Fund for the period up to 30 April 2009, anticipating a deficit of £8,700 being incurred in financial year 2008/2009, and a balance on the Fund's Revenue Account of £94,252 at 31 March 2010.

212. BUDGET STATEMENT

There was submitted a report by the Executive Director (Corporate Services) (09/215) (1) advising that, in terms of expenditure, the financial assistance budget had been increased to take into account the previous award of a contribution to Diabetes Research (Art. 537/08 refers); (2) advising that in terms of income, while the rent element of the budget would be retained at the same level as 2008/2009, the interest element was anticipated to be significantly reduced based on the latest information on interest rate levels; and (3) seeking approval of the Aberfeldy Common Good Fund Budget for financial year 2009/2010.

The Aberfeldy Common Good Fund Budget for financial year 2009/2010 be approved, as detailed within Report 09/215, with an anticipated deficit for 2009/10 of £8,700, and the Fund's Revenue Account Balance being £94,252 at 31 March 2009.
