- (3) Remuneration Figures and relevant allowances were subject to Pay as You Earn and National Insurance Contributions.
- (4) Travel & Subsistence Expenses where claimed were paid only on provision of appropriate receipts.
- (5) Reimbursement of expenses for overseas trips are included in the travel and subsistence columns.
- (6) Telephone and Information Communication Technology Support – Support costs for Telephone and Information Technology provision are met by the Council.
There is no refund of any of the costs to elected members. The variation in support costs allocated to each elected member reflects the cost of supporting Homeworking, annual rental costs for Blackberry's, and replacement/upgrade costs of Blackberry's.
The balance relates to costs incurred on telephone calls carried out as part of Council activities for which no refunds are made.
- (7) Civic Allowance - The Civic leader of the Council can incur expenditure up to a maximum of £3000 to support his/her activities. No call has been made on this provision for 2010/2011
- (8) Training - All Councillors have participated in a comprehensive programme of training, development and awareness raising sessions.
Each Councillor has a role description, has participated in a training needs assessment and had a personal development plan in place by 31March 2011
Training costs refer only to expenditure incurred as a result of employing external providers.
- (9) A Mileage Rate of £0.95 has been identified relating to costs associated with the provision of a vehicle for use by the Provost and other nominated Councillors fulfilling civic/ceremonial duties.
Staff costs associated with driving time for the civic vehicle have been estimated at an average of £13.50 per hour in addition to mileage costs.
- (10) The format of this report has been prescribed by SLARC to ensure consistency of interpretation between all Scottish Local Authorities.
