APPLICATION FORM FOR VACANT PROPERTY EXEMPTION

EXPLANATORY NOTE

When a property is unoccupied and completely unfurnished, it may be exempt from Council Tax for a maximum period of 6 months.

If it remains unoccupied and unfurnished a 50% discount may be awarded for a further period of 6 months. Thereafter the level of discount will reduce to 10%.

Any application for exemption must be made by the person who is liable to pay Council Tax for the property, or an agent acting on his/her behalf. If the circumstances change you must notify us immediately.
