### 129. BYELAWS PROHIBITING CONSUMPTION OF ALCOHOL IN DESIGNATED PUBLIC PLACES

There was submitted a report by the Executive Director (Housing and Community Care) (08/108) seeking approval to (1) amend the existing byelaws prohibiting the consumption of alcohol in public places to include Aberfeldy, Coupar Angus, Dunkeld and Birnam, Errol and Scone; and (2) submit proposals to the Scottish Government for their confirmation. The report also referred to the need to amend alcohol byelaws to reflect changes introduced by the Licensing (Scotland) Act 2005.

#### Resolved:

- (ii) All alcohol byelaws be amended in the light of changes in alcohol licensing legislation.
