700. DECLARATIONS OF INTEREST

There were no Declarations of Interest made in terms of the Councillors' Code of Conduct.

701. T IN THE PARK: FUTURE FRAMEWORK FOR LICENSING CONDITIONS AND ARRANGEMENTS FOR MULTI-AGENCY WORKING GROUP

There was submitted a joint report by the Chief Executive and the Depute Director (Environment) (08/650) seeking agreement in principle to move towards Public Entertainment Licensing conditions for T in the Park, based on individual plans for functional areas, which also reflected the proposed new structure for the T in the Park Multi-Agency Group.

Resolved:

- (i) The principle of future licensing conditions for T in the Park based on a set of general conditions linked to individual plans, developed for issue-based activities, as outlined in Appendix 1 to Report 08/650, be approved.
- (ii) The Chief Executive and the Depute Director (Environment) be instructed to submit detailed proposals on the new arrangements to a future meeting of the Licensing Committee for approval.

702. PUBLIC ENTERTAINMENT LICENCE: T IN THE PARK MUSIC EVENT, BALADO AIRFIELD, KINROSS

There was submitted a report by the Chief Executive (08/651) advising of an application received by DF Concerts/Big Day Out for a variation of conditions in respect of the public entertainment licence for the T in the Park Music Event at Balado Airfield, Kinross to allow an additional 5,000 ticket sales to the public, all of which additional tickets to be camping tickets only.

An addendum to Report 08/651 was tabled at the meeting superseding paragraphs 3.1 to 3.3 of the report and seeking approval to introduce 5,000 Friday, Saturday and Sunday day tickets, without camping, for sale to the public, a percentage of which would be made available to local residents and the remainder to be sold as part of a Citylink travel package.

The applicant and current licence holder appeared before the Committee and answered members' questions. Representatives of the Chief Constable; the Chief Fire Officer; the Scottish Ambulance Service and Perth and Kinross Council's Environment Service also answered members' questions.

Resolved:

- (i) The variation in the conditions attached to the public entertainment licence in respect of the T in the Park Music Event at Balado Airfield be approved as detailed in the Report 06/651 and the addendum thereto, and the breakdown of tickets to be:
