(6) Telephone and Information Communication Technology Support – Support costs for Telephone and Information Technology provision are met by the Council.

There is no refund of any of the costs to elected members. The variation in support costs allocated to each elected member reflects the ongoing computer replacement programme (£496.35 per unit), annual rental costs for Blackberry's (£240) and replacement/upgrade costs of Blackberry's (£280.00 per unit).

The balance relates to costs incurred on telephone calls carried out as part of Council activities for which no refunds are made.

(7) Civic Allowance - The Civic leader of the Council can incur expenditure up to a maximum of £3000 to support his/her activities. No call has been made on this provision for 2007/2008.

(8) Training - All Councillors have participated in a comprehensive programme of training, development and awareness raising sessions.
