

Application for Free School Meals/Assistance with School Clothing/Footwear Guidance Notes for Applicant – 2018/2019

YOU MUST READ THESE GUIDANCE NOTES BEFORE COMPLETING YOUR APPLICATION Application forms for the start of school session 2018/2019 cannot be processed until after 1 July 2018 and should not be submitted prior to this date. Supporting evidence from Jobcentre Plus must be dated within 6 weeks of the date of your claim and Tax Credit Award Notices (TC602) must relate to financial year 2018/2019. FREE SCHOOL MEALS (FSM)

Please see attached application form for qualifying benefits

- Free School Meals are now offered to ALL pupils in P1- P3 without the need for parents/carers to submit an application form. However, this application form must be completed if you also require assistance with school clothing/footwear for your child in P1-P3.
- If you are between 16 and 18 years old and receive any of the qualifying benefits listed on the application form, you can apply for free school meals in your own right.
- Please note: Free school meal entitlement is valid only for the current school year (August 2018 to June 2019). A NEW APPLICATION IS REQUIRED FOR EACH SCHOOL YEAR.
- Claims cannot be backdated and entitlement will start from the date valid applications are approved.

ASSISTANCE WITH SCHOOL CLOTHING/FOOTWEAR (SC/F)

Please see attached application form for qualifying benefits.

- Parents/carers in receipt of a qualifying benefit will receive £100 per child in Primary and Secondary School. Assistance with school clothing/footwear is **not** awarded to nursery pupils.
- Children over 16 who are eligible to apply for an Education Maintenance Allowance will **NOT** be entitled to a clothing grant (contact secondary schools or Pullar House reception for further information).
- Please note only one application will be granted within each school year (August 2018 to June 2019).

TO ENABLE US TO PROCESS YOUR APPLICATION PROMPTLY, PLEASE:

- Ensure that you complete the information requested in all sections. List all of your children (regardless of Perth & Kinross school attended) on the same application form.
- Ensure that the application gives details of the person receiving the qualifying benefit and is signed by that person.
- Note if you are applying for free school meals under the criteria of Child Tax Credits and/or Working Tax Credits, you must provide a full copy of your current (2018/2019) Tax Credits Award Notice (TC602).
 If you have been issued with a Tax Credit Annual Review notice (TC603) and your circumstances have not changed from last year, you should submit this notice along with the last Tax Credit Award Notice you received.

IMPORTANT NOTES No payments for Assistance with School Clothing/Footwear will be made prior to 01 August 2018

In order to avoid delays please check that all information requested is included with your application. This will assist us to complete processing procedures before school commences in August. Please note however that applications received after 01 August 2018 may not be processed in time for the start of the new school term.
