Bring Your Empty Property Back to Life!

Perth & Kinross Council have operated a range of empty homes initiatives since 2012. This publication aims to make owners of empty properties aware of services and incentives that the authority has to help owners make decisions about empty properties and in turn make them revenue generating assets.

Owners of empty properties should be aware of the recent Local Government Finance (Unoccupied Properties etc) (Scotland) Bill whose powers came into force on 1 April 2013. Perth & Kinross Council have implemented this legislation and now apply 100% Council Tax to properties that have been empty for over twelve months. This will increase to 130% from April 2015. The Scottish Government are eager to encourage owners of empty homes to bring them back into use in order to increase housing supply and in particular to help tackle the shortage of affordable accommodation.

Perth & Kinross Council strongly endorse and support the Scottish Government's empty homes commitment and in response have developed a range of grants and advice services to assist owners of long-term empty properties make decisions about their use.

We appreciate that properties lie empty for many different reasons and we understand that for many owners the thought of bringing a long-term empty property back into use can be overwhelming and financially difficult. So we hope that you find this first edition of Perth & Kinross Council Empty Homes Focus useful and interesting.

Your Empty Property Can Make a Difference

Bringing empty properties back into use has long been on the Scottish Government's agenda. In 2007 the discussion document Firm Foundations announced that there would be a review of the private rented sector. The review highlighted the importance of bringing empty properties back into use and the varied benefits that this would bring to the built environment, meeting local housing need and helping local authorities meet their duties towards homeless people.

It is not a statutory requirement for local authorities to participate in empty homes work but Perth & Kinross Council could immediately see the benefits of bringing empty properties back into use.

To us empty properties are more than just empty, they provide us with an opportunity to regenerate Perthshire, boost the supply of housing for rent and sale and particularly to tackle the shortage of good quality affordable private accommodation.

Initiative Grants

Empty Homes Initiative Grants are available to owners of long-term empty properties that fail to meet the Repairing Standard. After a formal grant application process owners could benefit from a grant of up to £5.000 per bedroom. Grants will be awarded to properties that require heating, plumbing, electrical and glazing upgrades. Unfortunately we don't give grants for the installation of new kitchens, bathrooms, floor coverings or décor but we will give successful applicants a £500 decoration allowance.

There are a number of conditions attached to the grant, one being that the property is made available to the Rent Bond Guarantee Scheme for a period of five years and that the property once refurbished is let at the Local Housing Allowance rate. Once the property is refurbished our Rent Bond Guarantee Scheme can market the property on your behalf and prepare tenancy agreements for your tenants.

The initiative was successful in securing additional funding for this financial year and we are keen to engage with as many empty property owners as possible. We are predominantly looking for one and two bedroom properties in Perth City but we will consider all properties and we will even consider properties that require change of use from commercial to residential.

Rent Bond Guarantee Scheme



Guarantee Scheme



Our Rent Bond Guarantee Scheme has been operating since 2010. For many customers wanting to rent privately and trying to save for a deposit and first month's rent is extremely difficult.

Our Bond facilitates an agreement between landlord and tenant and allows a deposit to be paid over twelve monthly installments. If a tenant defaults on their bond and if it is not paid in full over the twelve month period, or if there is damage to a property when a tenant leaves, the landlord can make a claim against the Bond.

Accommodation Officers ensure that prospective customers are adequately vetted before accepting them to the scheme. Our accommodation team will support both landlord and tenant throughout a tenancy and can give advice and assistance relating to tenancy agreements and rent payments. An additional incentive is that customers who are in receipt of Housing Benefit will have their rent payments fast tracked to their landlord.

Our Accommodation Officers have a wealth of knowledge and expertise and are happy to discuss the Rent Bond Guarantee Scheme with prospective and established landlords.

Becoming a Registered Landlord

If you are considering renting your empty property you must become a Registered Landlord. It is a Statutory Requirement to register with the Local Authority in terms of Part 8 of the Anti-Social Behavior etc (Scotland) Act 2004. If you haven't applied to become a Registered Landlord you will be committing a criminal offence if you let or attempt to let a residential property.

You can apply online to become a Registered Landlord at Landlord Registration Scotland. By using this method you will receive a 10% discount. Alternatively you can download a landlord registration application form from our website:

It costs $\pounds55$ to become a Registered Landlord and $\pounds11$ to register each property you want to rent. Registration lasts for three years.

Vacant Property Development Officer

Our Vacant Property Development Officer is here to provide advice to owners on how to sell, rent, repair or convert properties to another use. This Officer also looks at problematic properties and owners who do not want to address or bring their empty property back into use.

If you want to do something with your empty property but you are not sure what, our Vacant Property Development Officer is at hand to give support and advice. There are a large amount of options to help ensure that appropriate and sensible solutions can be found for owners.

Feasibility Funding

Do you have an empty commercial premises but think it would be good to convert it to residential premises or have a property that you think could have an alternative use? If so our Vacant Property Feasibility Funding could be for you!

You could apply for a grant of up to £5,000 towards architect or surveyor fees to help you realize your property's full potential.

There are certain conditions attached to this grant but once the property has been refurbished there is no condition that it should be made available to customers of the Rent Bond Guarantee Scheme. However this grant can be blended with our Empty Homes Initiative Grant (conditions apply).

Matchmaker Scheme

Perth & Kinross Council's Matchmaker Scheme has been set up to help prospective buyers and sellers of empty properties find each other more easily. The condition of the property for sale does not matter as some buyers may be looking for a complete project, whilst others may just be looking for a property that needs updating.

Not all empty home owners have the time or financial resources to return their property to use, and sometimes the best solution is to sell the property to someone who can. This is a hassle-free option if you've been thinking about selling your empty property but not quite made up your mind.
