335. DECLARATIONS OF INTEREST

There were no declarations of interest made in terms of the Councillors' Code of Conduct.

336. MINUTE OF PREVIOUS MEETING

The Minute of the Licensing Committee of 31 May 2012 (Arts. 221-230) was submitted and approved as a correct record.

337. LIMIT ON TAXI NUMBERS IN PERTH

There was submitted a report by the Head of Legal Services (12/290) (i) outlining the findings and recommendations of a recent survey of demand for taxis in Perth and (ii) proposing that the limit of seventy taxis for Perth City remain unchanged.

Resolved:

The Committee agreed:

- (i) the findings and recommendations of a recent survey of demand for taxis in Perth be noted; and
- (ii) the limit of seventy taxi operator licences for the Perth area remain unchanged.

338. GRANT OF HMO LICENSING AT 5/7 BALHOUSIE STREET PERTH - HMO185

There was submitted a report by the Head of Legal Services (12/291), together with letters of objection from residents of neighbouring properties, dated 4 May 2012, 12 May 2012, 15 May 2012, 16 May 2012 and 17 May 2012, regarding an application for Grant of HMO Licence at 5/7 Balhousie Street, Perth.

The applicant and his Agent were in attendance, addressed the Committee and answered members' questions. Mr A Duffy, Ms C Shufflebotham and Mr J Kirkhope, objectors to the application, and Ms D Merchant, Licensing Officer, also addressed the Committee and answered members' questions.

FOLLOWING A SHORT ADJOURNMENT, THE COMMITTEE RECONVENED.

Resolved:

Grant of HMO Licence HMO185 be delegated to the Clerk of the Licensing Committee, subject to the imposition of appropriate conditions.

Councillor D Melloy made an Amendment that Grant of HMO Licence HMO185 be refused, on the grounds that the premises were the wrong type for use as a House in Multiple Occupation and would accommodate too many people. On failing to secure a Seconder, the Amendment accordingly fell.

339. GRANT OF STREET TRADER'S LICENCE – ST264 AND VARIATION OF CONDITION 7

There was submitted a report by the Head of Legal Services (12/292), together with (i) letters of objection from neighbouring residents dated 25 June 2012 and 28 June 2012; and (ii) letter of objection from the Chief Constable, Tayside Police, dated 11 July 2012 (tabled at the meeting), regarding an application for (i) Grant of Street Trader's Licence ST264 and (ii) Variation of Condition 7 of Street Trader's Licence ST264 be granted).
