Transport and Travel Information

All the transport and travel measures are planned in support of safe, healthy and sustainable travel to school and are set within a context of parents and carers having the ultimate responsibility for ensuring the safe travel of their child(ren) to and from school.

Crossings

New Toucan crossings have been installed on The Muirs, north of Lathro Park and north of Gallowhill Road, and on Lethangie Road to assist safer travel to the campus.

School Crossing Patroller (SCP) 🛛 🥮

To assist with safer travel to school, a School Crossing Patroller will be working at the new Toucan crossing on The Muirs, south of the campus.

The crossings and the SCP provision will be monitored closely by the Travel Plan Steering Group for the campus in consultation with the Council's Traffic and Road Safety Team and Education and Children's Services. Other potential areas for SCPs will be monitored once travel patterns to the campus are established.

Speed Limit



A part-time mandatory 20mph speed limit will apply along part of The Muirs and Lethangie Road during term time. The existing 30mph speed limit on Lethangie Road will be extended to include the front of the campus.

School Transport

School transport arrangements will not change significantly following the move to the campus. All existing school transport will continue to operate. The Council's Public Transport Unit has written to all pupils entitled to free home to school transport with details of any changes to their bus timetables.

Free transport is normally only provided to secondary school pupils who live more than three miles away from their catchment school measured by the shortest available walking route.

The alighting/boarding of school transport vehicles on the campus will be closely supervised by school staff.

Parents

Parents are encouraged not to use a car to drop off Kinross High School pupils in the immediate vicinity of the campus because of the congestion and road safety risks that will be created if they enter the campus premises or adjoining roads.

Park and Stride

The provision of alternatives to school travel by car will be investigated by the Travel Plan Steering Group.

Campus Access by Public Transport

From 29 October 2009, the Council will be providing a bus link between the campus and residential areas in both Milnathort and Kinross, and other local communities nearby. Further details and timetable information will be available from the Public Transport Unit on 0845 30 111 30.
