A Campus Travel Plan is intended to bring benefits for safety, health and the environment.

## Transport and Travel Information

All the transport and travel measures are planned in support of safe, healthy and sustainable travel to school and are set within a context of parents and carers having the ultimate responsibility for ensuring the safe travel of their child(ren) to and from school.

## School Crossing Patroller (SCP)




A School Crossing Patroller will continue to work at the Five Ways Road junction.

The SCP provision will be monitored closely by the Travel Plan Steering Group for the campus, in consultation with the Council's Traffic & Road Safety Team and Education & Children's Services. Other potential areas for SCPs will be monitored once travel patterns to the campus are established.

## Speed Limit

A part-time mandatory 20mph speed limit will apply along part of Pittenzie Road during term time.

The current mandatory 30mph speed limit on Pittenzie Road will be extended to the junction with Broich Road. A new mandatory 40mph speed limit will also be introduced on Broich Road from the existing 30mph zone past the junction with Pittenzie Road.

## Crossings

There are no pedestrian crossings currently planned as part of the transport and travel measures for the campus. However, as with SCP provision, this matter will be monitored closely by the Travel Plan Steering Group together with Council Services.

## School Transport

School transport arrangements will not change significantly. Travel information issued at the start of the 2009/2010 school year to the parents of pupils entitled to free home to school transport is still valid.

The Council's Public Transport Unit will write to any families where drop-off/pick-up arrangements for school transport have altered.

Free school transport is normally only provided to secondary school pupils who live more than three miles away from their catchment school measured by the nearest available walking route.

School staff will closely supervise pupils getting on and off school transport vehicles on Pittenzie Road.

## Campus Access by Public Transport

From 12 November 2009, the campus will be included on the route of the Crieff town bus, Service 45, to enhance access to the campus for the local community. Further details including timetable information will be available from the Public Transport Unit on 0845 30 111 30.

## Other Developments

The provision of alternatives to school travel by car will be investigated by the Travel Plan Steering Group.
