SOCIAL CARE COMMISSIONED SERVICES CONTRACT VALUES AND MONITORING ARRANGEMENTS

Report by Executive Director (Housing and Community Care)

ABSTRACT

This report advises Committee of the contract values and monitoring arrangements for social care services commissioned by Housing and Community Care for 2012-13.

1. **RECOMMENDATIONS**

It is recommended that Committee:

- 1.1 Notes the levels of funding awarded for 2012-13 to social care commissioned services (Appendices 1 3).
- 1.2 Notes the monitoring and contract management arrangements in place to deliver agreed outcomes and value for money.

2. BACKGROUND

- 2.1 On 19 May 2010 Housing and Health Committee approved the Housing and Community Care Services Commissioning Strategy (Report 10/252). This set out the arrangements for commissioning services from external providers and summarised the areas of expenditure on services based on the agreed priorities of joint community care strategies. The strategy identified that over 75% of community care services' net expenditure was spent on externally commissioned delivered services.
- 2.2 Strategic commissioning has been defined by the Audit Commission as "all the activities involved in assessing and forecasting needs, agreeing desired outcomes, considering options, planning the nature range and quality of future services and working in partnership to put these in place".
- 2.3 The Strategic Policy and Resources Committee on 14 September 2011 approved the Annual Report for Following the Public Pound (Report 11/463). The report before Committee today advises on the complementary information required under the 'Following the Public Pound' arrangements whereby an annual report is to be provided to the relevant approving committee on contract and grant values which may not always be fully available in summary budget reports. The report also satisfies a recommendation to provide detailed information on social care contract values which arose from a recent internal audit report on commissioned services.

3. HOUSING AND COMMUNITY CARE CONTRACT MANAGEMENT & MONITORING ARRANGEMENTS

- 3.1 Housing and Community Care Services have a number of contractual mechanisms in place to help deliver the service's strategic objectives and outcomes. These are:
 - National Care Home Contracts a national contract which provides the framework for purchasing care home placements for local authority funded residents.
 - Pre-Placement Agreements for approved care at home providers agreements with providers which enable the purchase of a care at home service at a set price or standardised rate.
 - Service Level Agreements agreements negotiated and entered into, predominantly with voluntary sector providers, to deliver an agreed service.
 - Block Contracts an arrangement where a fixed level of service is purchased at a fixed price over a set period. These are in place where services have been tendered competitively or a specialist type of service has been subject to contract negotiation on price and level of service specification.
 - Spot Purchasing where a specific type and volume of care and/or support is purchased on a case by case basis for specific named individual.
- 3.2 The purpose of the report is to appraise Committee of the range, type and value of services which are purchased by these means.
 - Appendix 1 provides a list of the Service Level Agreements, Block Contracts and Individual Placement Agreements which are in place for 2012 -13, to a total value of £13.793 million.
 - Appendix 2 provides a list of Care Homes in Perth and Kinross operating within the National Care Home Contract, which is form of pre-placement contract, where the Council makes placements. The level of spend for 2012-13 is £19.253 million.
 - Appendix 3 provides a list of the care at home agencies operating under pre-placement agreements in Perth and Kinross. The level of spend for 2012 -13 is £5.5 million.
- 3.3 The Scottish Government has identified joint commissioning with local health care agencies and the independent sector as a major priority in the integration of health and adult care. Future committee reports will outline the detail of such arrangements once confirmed with the Scottish Government.
- 3.4 The Regulation of Care (Scotland) Act 2001 provides the legal basis for the application of National Care Standards for services and Codes of Practice for social services' workers and employers. These duties are discharged by the Care Inspectorate and the Scottish Social Service Council respectively.

- 3.5 All social care services which are commissioned by Housing and Community Care are subject to comprehensive monitoring and contract management processes undertaken by the Commissioning and Contracting Team. The focus of the monitoring is to ensure the services purchased are delivered in alignment with Council priorities and are focused on delivering desired outcomes, at appropriate standards and prices.
- 3.6 There are four main themes which provide a framework for Housing and Community Care's monitoring function. These are:
 - Strategic relevance and demand.
 - Service delivery and quality.
 - Value for money.
 - Organisational capacity and capability.
- 3.7 The level and scope of monitoring undertaken is driven by a risk-based approach, designed to ensure that more attention is focused on services which require improvement. Where services are considered as requiring closer scrutiny, designated monitoring officers carry out monitoring visits, or conversely, if services are considered as delivering on the themes mentioned above, a desk-top monitoring exercise is conducted.
- 3.8 Monitoring reports are prepared using information gathered from monitoring visits, performance and outcomes information submitted by the providers, feedback from stakeholders, client and families/carers. Where improvements are required these are delivered in an improvement action plan which is agreed with the provider and followed through to completion.
- 3.9 To ensure that there is an overview and scrutiny of all contract management arrangements a Purchased Services Board meets on a bi-monthly basis. This is chaired by the Head of Housing and Strategic Commissioning and includes the Head of Community Care with representatives from the Commissioning and Contracting team, finance and colleagues from the Community Health Partnership and Education and Children's Services.
- 3.10 Strategic commissioning is increasingly important at a time of financial constraint and social policy change. Several areas are worthy of note:
 - Over the last 2 years, all contracts and service level agreements were reviewed and scrutinised to make sure services were providing value for money. In addition, many contract values were reduced to enable Housing and Community Care to meet planned budget efficiency measures for commissioned services.
 - Commissioning which is focused on achieving positive outcomes is central to the delivery of social care services. As part of the contract monitoring process the Commissioning and Contracting team works in partnership with providers to specify services based on desired outcomes.
 - The Service works in partnership with providers through reference groups and providers' forums. Reference groups exist for mental health and

learning disabilities services' providers and operate along similar lines to the well established fora for care homes and care at home providers.

 Self-directed support will influence the way in which social care services are purchased over the next few years, as an increasing number of care and support packages will be delivered through Direct Payments or purchased on an individual basis. The Contract and Commissioning team will be involved in re-aligning contracts, making sure the quality of care of managed and part-managed packages is appropriate. Services delivered through Direct Payments are commissioned by individuals rather than the Council and are therefore outwith the scope of this report.

4. PROPOSALS

- 4.1 It is proposed that Committee notes the levels of funding awarded for 2012-13 to commissioned social care services as set out in Appendices 1 -3.
- 4.2 It is further proposed that Committee notes the monitoring and contract management arrangements that are in place to ensure the delivery of agreed outcomes and value for money.

5. CONSULTATION

The Heads of Democratic Services, Legal Services and Finance and the Chief Social Work Officer have been consulted on the content of this report.

6. **RESOURCE IMPLICATIONS**

- 6.1 The expenditure on commissioned services under Service Level Agreements and Block Contracts approved for 2012-13 is £13,793,564. As indicated earlier in this report, the projected expenditure on Care Homes £19,253,600 and Care at Home contracts is £5,500,000. Together expenditure equates to a projected contractual spend for 2012-13 to £38,547,164.
- 6.2 The core activities and priorities identified in this report have been incorporated into the Service's revenue budget following approval at full Council on 9 February 2012 of the Council's Revenue Budget for 2012/13 (Report 12/52).

7. COUNCIL CORPORATE PLAN OBJECTIVES 2009-2012

The Council's Corporate Plan 2009-2012 lays out five Objectives which provide clear strategic direction, inform decisions at a corporate and service level and shape resources allocation. The following apply to this report:-

- (i) A Safe, Secure and Welcoming Environment
- (ii) Healthy, Caring Communities
- (iii) A Prosperous, Sustainable and Inclusive Economy
- (v) Confident, Active and Inclusive Communities

8. EQUALITIES IMPACT ASSESSMENT (EqIA)

- 8.1 The Council's Corporate Equalities Assessment Framework requires an assessment of functions, policies, procedures or strategies in relation to race, gender and disability and other relevant equality categories. This supports the Council's legal requirement to comply with the duty to assess and consult on relevant new policies to ensure there is no adverse impact on any community group or employees.
- 8.2 The function, policy, procedure or strategy presented in this report was considered under the Corporate Equalities Assessment Framework and assessed in relation to the Race/Disability/Gender Equalities Assessment. Consequently the following points were identified and actions
 - Services that are the focus of this report provide positive outcomes through care, support and assistance to a range of client groups.

9. STRATEGIC ENVIRONMENTAL ASSESSMENT

- 9.1 Strategic Environmental Assessment (SEA) is a legal requirement under the Environmental Assessment (Scotland) Act 2005 that applies to all qualifying plans, programmes and strategies, including policies (PPS).

This is because the Committee are requested to note the contents of the report only and the Committee are not being requested to approve, adopt or agree to an action or to set the framework for future decisions.

10. CONCLUSION

This report provides information on the levels of funding awarded for 2012-13 to commissioned social care services and sets out the monitoring and contract management arrangements in place to ensure the delivery of agreed outcomes and value for money in Housing and Community Care Services.

Appendix 3 – Housing and Community Care Social Care Commissioned Services 2012/13 (Care at Home Providers)

Note: Standardised rates for home care have been in place since 1 April 2009 and are £13.93 per hour local (within 10 miles of providers Perth and Kinross base) or £14.46 non local (out with 10 miles of providers Perth and Kinross base). It should be noted that following the implementation of a re-ablement service, several providers were successful in the being designated as core providers following a competitive process. Care Services, Carewatch and Gowrie Care Itd are designated core providers for Perth city and Elite Care (Scotland), Gowrie Care and ILS are designated core providers for rural areas.

Some providers are also approved to provide care at home services in Perth and Kinross. Several of these providers provide specialist care and support for individual packages but they are not routinely purchased for care at home at the standardised rates and are presently defined as 'inactive'.
