**ALMONDBANK FLOOD PROTECTION SCHEME 2013
FLOOD RISK MANAGEMENT (SCOTLAND) ACT 2009 and
THE FLOOD RISK MANAGEMENT (FLOOD PROTECTION SCHEMES, POTENTIALLY
VULNERABLE AREAS AND LOCAL PLAN DISTRICTS)(SCOTLAND) REGULATIONS 2010**

I refer to my letter of 1 July 2013 notifying you of the above Scheme under the above Act and Regulations.

I now write to notify you that Perth and Kinross Council's Environment Committee confirmed the Almondbank Flood Protection Scheme 2013 with no modifications on the 20th November 2013.

The enclosed Notice will be published in the Courier and the Edinburgh Gazette, and displayed in a prominent position throughout Almondbank and Lochty on 29th November 2013. The Scheme will become operative six weeks after this date unless an appeal is made against the Scheme. Further information on making an appeal is included in the Notice.

If no appeal is made then the Scheme will become operative from 10th January 2014. This does not mean that construction of the Scheme will commence: simply that the Council has the necessary statutory power to construct the Scheme when the appropriate time comes.

Upon completing this process and funding being in place, the Council will re-engage consulting engineers to commence the detailed design for the Scheme. Construction would begin at a later stage. In the meantime, the Council will continue to keep the community informed of progress.

The Scheme's website, at www.pkc.gov.uk/almondbankfloodscheme, will be updated periodically to provide you with the latest details on the progress of the Scheme.
