BE SAFE BE SURE NATIONAL PRIVATE FOSTERING CAMPAIGN 2-6 DECEMBER 2013

The purpose of this letter is to request your help in raising awareness nationally about private fostering.

Private fostering is when a private childcare arrangement is made between parents and other adults who are not close relatives (i.e. not a grandparent, brother, sister, uncle or aunt) of the child or not formally approved foster carers and where the care of the child is to be undertaken for more than 28 days.

The law states that these arrangements need to be brought to the attention of local authority Children's Services Departments so that they can ensure the wellbeing of the child(ren) involved. Since there are been very few of these arrangements brought to the attention of local authorities in Scotland, there are concerns that many more may exist, leaving some children in potentially vulnerable circumstances.

We would like to raise awareness about private fostering with as many services as possible working directly with children and families in Scotland. The enclosed campaign materials have been designed to help encourage parents, carers and service providers to notify local authorities of any private fostering arrangement they are involved in or are aware of.

Distribution

We have made arrangements for hard copies to be sent to schools, GP Practices, Police stations, libraries, UKBA and Citizens Advice Centres and some local authority children's services that will be supporting the campaign locally. These services will receive this letter along with their hard copies.

We are also publishing good practice guidance for local authorities on how to handle private fostering arrangements and have arranged to have a link and downloadable versions of the leaflets and poster available on our website at www.scotland.gov.uk/privatefostering.

We would be grateful if you could arrange for service providers dealing directly with children and families within your area of work to display a poster and have leaflets for parents available in any public areas where parents or carers will have access. Also to ensure that service workers are made aware of the information leaflet for service providers. We are also preparing a radio focus on local radio stations to support the work of the campaign during the week 2-6 December.
