1. DECLARATIONS OF INTEREST

There were no declarations of interest.

2. ELECTION OF CONVENER/VICE CONVENER

In discussion the following points were noted:

(i) Spittalfield – SPIT/124

N Cole reported that walkers may possibly have been deterred from walking in the area due to advice on shooting from the keeper. The Estate would be contacted to clarify position on signage when shooting was taking place.

(ii) Pitcastle Estate - 00887

The Forum agreed that further investigation was required regarding the fencing and signage around the wildlife enclosure. It was agreed that N Cole, P Pearson, R Payne and W Lindsay would undertake a site visit on Wednesday 11 December at 10:00am.
