Position Statement on Supporting Syrian Refugees

Executive Director (Housing and Community Care)

PURPOSE OF REPORT

To inform committee of the Council's commitment to offer accommodation and support for refugees from Syria.

1. BACKGROUND / MAIN ISSUES

- 1.1 COSLA recently circulated a Briefing to local authorities advising of a scheme for the accommodation of Syrian refugees who have fled the ongoing conflict in that country. The UK Government has announced that it intends to relocate some of the most vulnerable refugees under what it has termed the Vulnerable Person Relocation scheme and is seeking notifications from local authorities that may wish to be involved in supporting this process.
- 1.2 During the Kosovan crisis in the 1990s Perth and Kinross Council planned to support a refugee relocation scheme similar to the one being proposed by using difficult-to-let houses in the Muirton area. However, this stock has now been demolished and there are no longer any significant concentrations of difficult to let stock anywhere in the Perth and Kinross area.

2. PROPOSALS

- 2.1 Although we have limited capacity within the social-rented sector and have a number of people on our housing waiting list, there are around 10,000 private-rented properties in the Perth and Kinross area, making up around 14% of our housing stock. As a result, we have been working in partnership with private sector landlords for several years and have helped over 700 households to access accommodation in this sector since 2009.
- 2.2 For Perth and Kinross Council to support the Vulnerable Person Relocation Scheme, the private rented sector will offer the greatest choice of properties to meet the specific needs of these Syrian families and individuals. The size and range of this sector and vacancy levels are such that accommodation could be identified at relatively short notice to support these very vulnerable individuals.

- 2.3 The COSLA briefing suggests that the UK Government will provide funding to cover the costs associated with this scheme for the first year.
- 2.4 Given the very difficult circumstances and experiences of the Syrian refugees we will need to make sure a range of agencies and services were ready and able to offer practical and emotional support, including:
 - Education and Children services support from the schools, as well and children and families social work services
 - Health Services
 - A range of other social work services, including mental health services
 - Translation services
 - MEAD / Women's Aid

2.5 **Financial Support**

The Syrian refugees would require a source of income to cover their daily living costs, which we could assume would be consistent with both existing DWP & Home Office rules on refugees and the policy guidance within the UK Government's Vulnerable Person Relocation Scheme.

3. CONCLUSION AND RECOMMENDATION(S)

- 3.1 Perth and Kinross Council is in a very good position in terms of the size of the private rented sector and the positive relationship that we have developed with private landlords and letting agents to house vulnerable refugees. Whilst we don't have details of the specific needs of the Syrians, it is anticipated that suitable vacancies could be identified at relatively short notice if required.
- 3.2 It is assumed that the UK Government would cover all of the associated costs of the scheme initially, although families and individuals who require to remain in Perth and Kinross for a longer period and may need access to further support for which additional negotiations will take place.
- 3.3 Committee is asked to agree in principle to respond positively to the Vulnerable Persons Notification Scheme and notify the UK Government accordingly. This agreement in principle is subject to Committee receiving further details of the scheme.
