

**PERTH AND KINROSS COUNCIL****Environment Committee****26 March 2014****SCOTLAND'S RESOURCE SECTOR COMMITMENT****Report by Depute Director (Environment)**

Scotland's Resource Sector Commitment (SRSC) sets out standards which will drive continuous improvement, excellent customer service, and to enable businesses to reduce waste and be more resource efficient.

By signing up to this voluntary customer and supplier commitment, Perth and Kinross Council will be able to demonstrate their support for Scotland's zero waste ambitions.

**1. BACKGROUND / MAIN ISSUES**

- 1.1 Perth and Kinross Council provides a well established and nationally recognised Commercial Waste & Recycling Service to businesses, organisations and our own internal Council Services. The customer interface is managed by the Waste Services' Commercial Waste & Contracts Team and the collections are undertaken by Direct Services (Operations).
- 1.2 The Council offers an integrated package of commercial waste and recycling collection services to businesses in the Perth and Kinross area. These are compliant with new Waste (Scotland) Regulations 2012 and with the Environmental Protection Act 1990.

Collection services currently include:

- Residual Waste
- Food Waste
- Glass (Mixed and colour segregated)
- Dry Mixed Recyclates (paper, cardboard, cans, plastics)
- Cardboard Recycling
- Garden waste
- Skip Hire (where at least 70% recycling is achievable from the waste collected)

- 1.3 Customer feedback is recorded through customer satisfaction surveys and meetings with businesses. The Council's Commercial Waste Team also signpost businesses to other sources of advice, training and funding.

- 1.4 Perth and Kinross Council is already a signatory to the Waste Collection Commitment, which sets out the principles for domestic waste collection services. This was agreed at the Environment Committee on 26 May 2010 (Report No. 10/266).

## 2. PROPOSALS

- 2.1 Scotland's Resource Sector Commitment has been developed jointly by the Scottish Government, Zero Waste Scotland, representatives of the resource management sector and its customers.
- 2.2 The Commitment has been developed to demonstrate the industry's commitment to Scotland's zero waste ambitions and delivering this commitment in relation to non-domestic customers. The Scottish Government's Zero Waste Plan targets a continuing shift away from the use of landfill towards investment in high-quality recycling and resource recovery, with a focus on maximising benefits to the Scottish economy, while also protecting the environment. These ambitions have been reinforced by the legal framework of the Waste (Scotland) Regulations 2012.
- 2.3 The objective of the voluntary agreement is to continue to progress towards a more resource efficient economy through an agreed set of actions and behaviours. The Commitment is detailed in Appendix 1.
- 2.4 The Commitment is for any organisation involved in providing waste or resource management services to commercial customers in Scotland. This includes:
- Local authorities
  - Private and third sector resource management businesses
  - Resource management associations and trade bodies.
- 2.5 Officers believe that Perth and Kinross Council already meets the requirements outlined in Scotland's Resource Sector Commitment. Details of these activities can also be seen in Appendix 1. By signing up to the Scotland-wide Commitment, the Council will be able to demonstrate that our waste & recycling customers will receive:
- High-quality collection & recycling services
  - Advice on preventing waste and using resources efficiently
  - Opportunities to provide feedback and ideas for improving our services
  - Clear and user-friendly contract management
- 2.6 It will also demonstrate that the Council is committed to helping businesses reduce waste, recycle more, save money and meet their legal responsibilities in managing waste, as well as demonstrate communicating service expectations to customers.

- 2.7 The Commitment supports the Perth and Kinross Economic Strategy (2009 – 2014) with a long term approach to build on the positive impact that caring for the environment could bring to the local economy, by stimulating job creation and business opportunities.
- 2.8 Resource management organisations, such as Perth and Kinross Council, can register their details or download the Commitment by visiting [www.zerowastescotland.org.uk/ResourceCommitment](http://www.zerowastescotland.org.uk/ResourceCommitment).
- 2.9 If the Environment Committee agrees to sign-up to this commitment, officers would inform Zero Waste Scotland. The Council will then be required to submit the evidence in Appendix 1 to demonstrate we meet the sign-up standards. Zero Waste Scotland would then inform the Council if we meet the standards set out.
- 2.10 13 organisations have already signed up to the Commitment. Perth and Kinross Council would be the 3rd Scottish Local Authority to do so, if approval is given to this report.

### **3. CONCLUSION AND RECOMMENDATION(S)**

- 3.1 Agreeing to Scotland's Resource Sector Commitment would provide the Council with an opportunity to demonstrate to the community and to our customers, the quality of our commercial waste and recycling services, benchmarked against an objective set of standards, developed nationally and supported by the Scottish Government. It would also provide a basis for continuing to improve commercial waste and recycling services, which represent value for money, and which meet the needs of our business customers.
- 3.2 It is recommended that the Environment Committee agree to sign-up to Scotland's Resource Sector Commitment.

Participating businesses were supported (through environmental audits and advice) so as to be able to implement actions that would bring about environmental benefits and cost savings for their business.
