### **Perth Christmas Lights Switch On**

## Report by Depute Director (Environment)

The report notes the activities for the Christmas Lights Switch On event on Saturday 22 November 2014 using the funding already approved by Perth Common Good Committee which is part of the overall Perth Winter Festival programme. The Committee is also asked to consider additional financial support to extend the events to Sunday 23 November 2014.

#### 1. BACKGROUND

- 1.1 The Perth Common Good Fund has traditionally supported the costs associated with the Perth Christmas Lights including erection, maintenance, storage, rent, feu duties and electricity charges. In addition, the Common Good Fund has supported the Christmas Lights Switch On event which has grown significantly in the past two years in terms of scale, scope and attendance. In 2013, it was estimated that 26,000 members of the public were in Perth City Centre for the Christmas Lights Switch On event, which was a 70% increase on the 2012 event, with an estimated £1.5 million generated for the local economy.
- 1.2 At its meeting of 7 May 2014 (Ref 14/178), the Perth Common Good Fund Committee approved the budget for Financial Year 2014/15 which included a provision of £81,300 for the Christmas Lights with £39,000 from this allocated for the Switch On event. This is scheduled for Saturday 22 November 2014 and this report outlines the proposed breakdown of expenditure associated with the event.
- 1.3 In line with the Council's Events and Festival's Strategy, the Perth Winter Festival was developed in 2013/14 as an overarching programme of events and celebrations lasting from Bonfire Night on 5 November until the Chinese New Year in February. The objective of the Festival is to generate additional economic benefits for the city through increased expenditure by visitors and residents while also contributing to the vibrancy and cultural life of the city, along with raising the profile of Perth as a leading events destination. It is intended to develop further the Festival for 2014/15 by enhancing existing events and introducing new elements. In particular, it reinforces the message that "Christmas starts in Perth" with an innovative programme of events and entertainments over the weekend of 22 and 23 November 2014 the highlight being the Christmas Lights Switch On.
- 1.4 Events and marketing expenditure for the Winter Festival is met from the Environment Service's revenue budget with private sector sponsorship also forthcoming for specific elements. In 2013/14, overall expenditure for the

Winter Festival, including marketing and events support, was £159,000 (of which the Common Good Fund contributed £39,000). The Common Good funding already approved in May is to support specific elements on Saturday, 22 November 2014 focussed on the Christmas Lights celebrations.

1.5 For 2014, a full programme of events and entertainments is being planned to create a weekend of celebrations in the city that appeals to a broad range of age groups. As with the past two years, it is intended that there will be opportunities for local community groups to participate in street and stage performances including a community stage in King Edward Street, along with the "Singing Christmas Tree" for choirs and musical groups at Horsecross Plaza. Artists for the main stage programme are currently being investigated but would comprise a range of musical acts including a local band, a covers band covering a range of genres, a contemporary band (similar to Luminites in 2013), a retro band (similar to the Bay City Rollers in 2013) and a star band/singer. An outline programme for Saturday 22 November 2014 is as follows:

1.6 The approved Perth Common Good Fund contribution will support the following elements of the programme on Saturday 22 November 2014:

Main stage (lighting, sound, pyrotechnic effects, and related infrastructure)	£20,000
Community Stage	£1,000
Santa's Parade and street entertainments	£10,000
Singing Christmas Tree	£3,000
Health, safety and welfare (medical cover, stewarding, toilets, waste services and cleansing)	£5,000

#### 2. PROPOSAL

#### Sunday 23 November 2014

2.1 Given the ambition to develop the weekend's activities, and the Winter Festival overall, some thought has been given to extending the programme to Sunday 23 November 2014. The Committee is asked to consider whether additional funding of £10,000 could be provided to support this.

Community Stage	£1,000
Street entertainments	£7,000
Singing Tree	£1,000
Health, safety, welfare	£1,000

- 2.2 The additional programme would also extend the opportunity for participation by community groups, particularly young people, into a second day and extend the celebrations over the weekend in a bid to drive further footfall to the city centre.
- 2.3 The impact of the programme of events will be assessed by public and business surveys along with analysis of footfall figures for the city centre.

#### 3. CONCLUSION AND RECOMMENDATIONS

3.1 The Christmas Lights Switch On event has been greatly enhanced since 2012. It is seen as a key feature of the Perth Winter Festival, which in turn is a new approach to branding and promoting a range of events in the city over the winter months.

#### 3.2 The Committee is asked to:

- i) Note the current budget provision from 2014/15 in respect of the Christmas Lights Switch On programme for Saturday, 22 November.
- ii) Approve the additional events and activities outlined in the report along with the additional funding of £10,000 to support an extension of the events to Sunday, 23 November 2014.

- 1.2 It is considered that the strategy and related actions will contribute to the following objective: Promoting a prosperous, inclusive and sustainable economy.

2.1 As part of the 2014/15 budget process, the Committee approved a budget allocation of £39,000 towards the Christmas Lights Switch On event. A breakdown of anticipated expenditure is provided in the report. In addition, a request is made for further funding of £10,000 to support additional elements for Sunday, 23 November in order to enhance the programme further.
