- (iii) With effect from September 2014, implement a 10 point deduction to the rent-pointing scores of all bedsits in recognition of the current anomaly between two-apartment double-bedroom properties and bedsits: currently only 10 points. This deduction to reflect the absence of a separate or partitioned dining area (5 points) and the absence of a separate double-bedroom (15 points) in accordance with the present rent pointing system.
