Summary

This report is to inform the Committee of a potential forthcoming planning application in respect of a major development at Strathallan Castle, Strathallan, Auchterarder for engineering and other operations to facilitate the establishment and use of a venue for the purposes of holding a music event. The use of existing buildings and land in July each year for the purpose of holding a music festival and associated activities.

BACKGROUND AND DESCRIPTION

- In accordance with the provisions of the Town & Country Planning (Scotland)
 Act 1997 as amended, the applicants submitted a Proposal of Application
 Notice on the 29 September 2014. The purpose of this report is to inform the
 Development Management Committee that a forthcoming planning application
 in respect of a major development at Strathallan Castle, Strathallan,
 Auchterarder is likely. Pre-application reports give the Committee an
 opportunity to raise issues which it would like to see addressed in the
 subsequent planning application.
- 2 The proposed development relates to the hosting of a music festival and associated activities/operations.
- The site includes Strathallan Castle and extends to the south to the Andrews Wood which sits to the north of the settlement of Tullibardine. The site extends to the south west with the Tullibardine to Caerlaverock public road forming the boundary. The boundary then traverses the North and South Castle Wood which effectively surrounds the western side of the castle. To the north the site is bound by the minor road which links Knappilands Poultry Farm to Kinkell Bridge. The boundary then runs southwards and for the majority follows the line of the public road between Kinkell Bridge and Tullibardine but turns west at the Strathallan and Andrews Wood. The site is made up of a mixture of features including numerous buildings, large open fields, woodland, water bodies and watercourses.

PRE-APPLICATION PROCESS

The Proposal of Application Notice (reference 14/00010/PAN) confirms that two public exhibitions are to be held. The first will take place on Thursday

20 November between 1600 and 2000 hrs at Auchterarder Community Church Centre in Auchterarder. The second will take place the following day on Friday 21 November at Strathearn Community Campus between 1600 and 2000hrs.

- The applicant has also undertaken to consult and invite local residents to the events by using a postal drop service which will target approximately 8000 properties. This leaflet will provide a location plan of the proposed site,

- together with a brief introduction of the proposal and details of the two community consultation events in Crieff and Auchterarder.
- The applicant has also undertaken to provide a website which supplies details and information regarding the proposal and to set up an email address where members of the public will be able to submit queries regarding the proposal to the applicant. The email address and website address are yet to be confirmed.
- The results of the community consultation will be submitted with the application as part of the Report on Community Consultation.
