APPLICATIONS FOR FINANCIAL ASSISTANCE**Report by Director (Environment)****PURPOSE OF REPORT**

The report asks Perth Common Good Fund Committee to consider 18 applications for financial assistance.

1. BACKGROUND

- 1.1 Perth and Kinross Council owns land and property which forms part of the common good of the former burghs in Perth and Kinross and has a statutory duty in terms of section 15 of the Local Government etc. (Scotland) Act 1994 to administer this land and property “having regard to the interests of the inhabitants” of those former burghs. This duty also applies to the administration of the associated common good funds.
- 1.2 The Common Good Funds have traditionally demonstrated their support to local residents and organisations by distributing grant. These grant awards allow individuals and local organisations to carry out a wide range of community based activities. For each application, the level of previous grant awarded is listed, but variances between years could be due to the numbers of participants. Retrospective applications are not accepted. However, if an application is received before the activities take place and cannot be considered at the following meeting because the papers have already been issued, the application will be considered at the following next meeting even if the activities have taken place between meetings. Therefore the Committee decision will only be known after the activities have taken place, and if the grant is not awarded, the applicant will have to fund the activities from its own funds.

2. PROPOSALS**Kids of Letham Association**

- 2.1 An application has been received from the Kids of Letham Association seeking a grant towards the cost of their annual summer trip. The trip was to Heads of Ayr Park and took place on 11 August. The total cost of the trip was £940 and the applicant has requested any contribution available from the Perth Common Good Fund. The applicant has previously benefited as detailed below. 10 people age 17+ took part together with 40 under 17 years of age. It is recommended that a grant of up to £350 is awarded in line with the guidance (Appendix 1 – Criteria 10). The grant will contribute to social inclusion.
- 2.2 Grants awarded to Kids of Letham Association from the Perth Common Good Fund:
- 2013/14 £315

Recommendation

- 2.3 Kids of Letham be awarded a grant of £350 towards the cost of their summer outing to Heads of Ayr Park.

Perth Shotokan Karate Academy

- 2.4 An application has been received from Perth Shotokan Karate Academy seeking a grant toward the purchase and installation of new equipment. The equipment will be installed in a rented industrial unit in North Muirton. Currently training is done on a bare floor, but it is not safe to perform some techniques. The Academy wishes to purchase and lay mats which will resolve this. As all competitions take place on mats, participants will benefit from being able to practice on the same type of surface. The Academy also intends to purchase and install punching bags and other ancillary equipment to provide supplementary training and the opportunity to improve fitness, technique and speed. The total cost of the project is £7,937.30. The applicant is requesting a grant of £6,437.30. The applicant has previously benefited as detailed below. It is recommended that a grant of up to £3,219 is awarded in line with the guidance (Appendix 1 – Criteria 4). The grant will contribute to social inclusion.
- 2.5 Grants awarded to Perth Shotokan Karate Academy from the Perth Common Good Fund:

- 2012/13 £2,095

Recommendation

- 2.6 Perth Shotokan Karate Academy be awarded a grant of £3,219 towards the purchase and installation of equipment.

Perth Academy Pupil

- 2.7 An application was received from a Perth Academy pupil seeking a grant towards the cost of attending a four week expedition to Ecuador, which comprised voluntary work, from 26 June – 25 July 2015. The total cost per pupil amounted to £4,500. The applicant asked for a contribution towards the cost. The applicant has never previously benefited from the fund. It is recommended that a grant of £250 is awarded in line with the guidance (see Appendix 1 – Criteria 8). The grant will contribute to social inclusion.

Recommendation

- 2.8 Perth Academy pupil be awarded a grant of £250 towards the cost of the voluntary work.

Perth & District Badminton Association

- 2.9 An application has been received from Perth & Kinross Badminton Association seeking a grant towards the cost of staging the Scottish Badminton Championships in February 2016. This is the fifteenth year that these national

championships have been held in Perth and will take place in the Bell's Sports Centre. The event puts a focus on Perth and will receive local and national publicity via the printed media, TV, radio and Scottish Badminton's website. The total cost is £15,725 and the applicant is seeking a grant of £6,000. A grant of £4,000 has been awarded from the PKC Events budget. It will also bring participants and spectators to Perth from throughout Scotland. The applicant previously benefited as detailed below. It is recommended that a grant of £3,000 is awarded in line with the guidance (see Appendix 1 – Criteria 2). Grants awarded to Perth & District Badminton Association from the Perth Common Good Fund:

- 2012/13 £1,250
- 2013/14 £2,050
- 2014/15 £2,500

Recommendation

- 2.10 Perth & District Badminton Association be awarded a grant of £ 3,000 towards the cost of staging the 2016 Scottish Badminton Championships.

Perth Student

- 2.11 An application has been received from a Perth Student seeking a grant towards the cost of a volunteer year in Nepal through the Project Trust. The applicant is a volunteer English Language Assistant. The project started in August 2015 and will finish in August 2016 and involves helping children with the skills they need to get accepted into one of the secondary schools in the area. As part of the programme, the student will have to learn Nepali in order to fully integrate with the local population. The total cost is £7,110 and the applicant is seeking a grant of £500. The applicant has never previously benefited from the fund. It is recommended that a grant of £400 is awarded in line with the guidance (see Appendix 1 – Criteria 8). The grant will contribute to the promotion of lifelong learning opportunities.

Recommendation

- 2.12 The Perth Student be awarded a grant of £400 towards the cost of their volunteer year in Nepal.

Our Lady's Primary School – Parent Council

- 2.13 An application has been received from Our Lady's Primary School – Parent Council seeking a grant towards the cost of taking pupils to the Perth pantomime on 14 December 2015. The total cost is £2,430 and the applicant is seeking a contribution towards the cost. The applicant previous benefited as detailed below. It is recommended that a grant of £700 is awarded in line with the guidance (see Appendix 1 – Criteria 10). The grant will contribute to social inclusion.

2.14 Grants awarded to Our Lady's Primary School – Parent Council from the Perth Common Good Fund:

- 2013/14 £700
- 2014/15 £700

Recommendation

2.15 Our Lady's Primary School – Parent Council be awarded a grant of £700 towards the cost of taking pupils to the Perth pantomime.

Perth YMCA (Perth Alive 2015)

2.16 An application has been received from Perth YMCA seeking a grant towards the cost of staging Perth Alive 2015 which took place on 29 August on North Inch. The event was aimed at bringing church and community groups together to showcase the resources available and to demonstrate the good work that goes on in individual communities. The event featured bands, DJs, sporting events, a free barbeque and other activities. The event provided information on topics such as debt advice & money management and youth opportunities including training and education. The total cost was £7,000 and the applicant is seeking a grant of £2,500. The applicant has never previously benefited from the fund. It is recommended that a grant of £2,500 is awarded in line with the guidance (see Appendix 1 – Criteria 2). The grant will contribute to social inclusion.

Recommendation

2.17 Perth YMCA be awarded a grant of £2,500 towards the cost of staging Perth Alive 2015.

Hope Pregnancy Crisis Centre

2.18 An application has been received from Hope Pregnancy Crisis Centre seeking a grant towards the cost of delivering a programme of lessons to schools from August 2015 to July 2016. Hope's schools team will raise awareness of the Hope Centre and convey that it is a safe, non-judgemental environment to come to and talk about unplanned pregnancy. The team will inform young people of the choices available in unplanned pregnancy. The team supports the Council's Education and Children's Services Personal and Social Inclusion Curriculum through providing lessons in schools for those in S1 to S6. The cost of the programme is £10,000 and the applicant is seeking a grant of £2,000. The applicant has never previously benefited from the fund. It is recommended that a grant of £2,000 is awarded in line with the guidance (see Appendix 1 – Criteria 12). The grant will contribute to social inclusion.

Recommendation

2.19 Hope Pregnancy Crisis Centre be awarded a grant of £2,000 towards the cost of delivering a programme of lessons to schools from August 2015 to July 2016.

Perth Junior Golfer

2.20 An application has been received from a Junior Golfer (aged 15) seeking a grant towards the cost of participation in a golfing event, the English under 16 Championship, in The Wirral from 17 to 20 August. The applicant has graduated to Tier 2 of the Scottish Academy and participates in events in Perth & Kinross and in all relevant Scottish events. The applicant is one of eight boys from the Academy who participated in the event. The total cost is £340 and the applicant is applying for the full amount. Whilst the applicant has never previously benefited from the Perth Common Good Fund, he has benefited from the Alyth Common Good Fund as detailed below. The applicant is now resident in Perth. It is recommended that a grant of £100 is awarded in line with the guidance (see Appendix 1 – Criteria 9). The grant will contribute to social inclusion.

2.21 Grants awarded from the Alyth Common Good Fund:

Recommendation

2.22 Perth Junior Golfer be awarded a grant of £100 towards the cost of participating in the golf event in The Wirral from 17 to 20 August.

Bowerswell Social Group

2.23 An application has been received from Bowerswell Social Group seeking a grant towards the costs of an outing, of 15 people, to see the musical Copacabana at North Inch Community Campus on 12 September. The total costs of the outing are £375 and the applicant is seeking a grant of £170. The applicant has previously benefited as detailed below. It is recommended that a grant of £105 is awarded in line with the guidance (see Appendix 1 – Criteria 10). The grant will contribute to social inclusion.

2.24 Grants awarded to Bowerswell Social Group from the Perth Common Good Fund:

- 2012/13 £280 & £315 (2 outings including Christmas)
- 2013/14 £280 & £210 (2 outings including Christmas)

Recommendation

2.25 Bowerswell Social Group be awarded a grant of £105 towards the costs of the outing on 12 September.

Live Active Leisure Limited

2.26 An application has been received from Live Active Leisure Limited seeking a grant towards events to celebrate 50 years of service delivery. The project is

entitled Live Active @ 50. The centrepiece will be focussed around a major event on either 24 or 25 October. This event, at Bell's Sports Centre, features Danny Macaskill, a professional Mountain Bike trials rider. Danny was born and raised in Dunvegan on the Isle of Skye. He enjoys a huge following across all age groups and along with another three riders has formed a team to deliver a Mountain Bike Stunt Show called the Drop and Roll Tour. The tour has gained significant momentum since its inception and now has sell out dates across Europe. The event will be widely marketed locally, regionally and nationally to ensure the potential economic benefits to Perth are realised in terms of secondary spend on food, drink, shopping and accommodation. In addition, there will be a programme of activities over 4 separate weekends across the area which will showcase activities and will include a special offer of one day within the month of pay and play prices at 1968 levels, which was the year Bell's Sports Centre opened. Total costs are £21,657.12 and the applicant is seeking a grant of £10,000. The applicant has never previously benefited from the fund. The grant will contribute to tourism development and have economic benefit. It is recommended that a grant of £10,000 is awarded in line with the guidance (see Appendix 1 – Criteria 2).

Recommendation

- 2.27 Live Active Leisure Limited be awarded a grant of £10,000 towards the cost of Live Active @ 50.

Take a Pride in North Muirton

- 2.28 An application has been received from Take a Pride in North Muirton seeking a grant towards the cost of planting the Argyll Road flower beds in North Muirton. Community Payback has dug out the beds, all schools are engaged locally and Perth Grammar School is keen to provide a senior pupil to join the committee. The proposal is to landscape the beds, which lie in the centre of the village/housing scheme. This will lead to an improved pride in the area and support wellbeing. The total cost is £5,730 (the cost of plants and shrubs from Westbank Nurseries or similar supplier) and the applicant is seeking a grant of £2,865. This will be match funded with a grant (application made) to the Community Environment Challenge Fund for the same amount. The applicant has never previously benefited from the fund. It is recommended that a grant of £2,865 be awarded in line with the guidance in Appendix 1 (Criteria 12).

Recommendation

- 2.29 Take a Pride in North Muirton be awarded a grant of £2,865 towards the cost of planting the Argyll Road flower beds in North Muirton.

Bowerswell Social Group

- 2.30 An application has been received from Bowerswell Social Group seeking a grant towards the costs of their Christmas Lunch, for 40 people, on 11 December 2015. The total costs are £700 and the applicant is seeking a grant of £400. The applicant has previously benefited as detailed below. It is

recommended that a grant of £280 is awarded in line with the guidance (see Appendix 1 – Criteria 10). The grant will contribute to social inclusion. Grants awarded to Bowerswell Social Group from the Perth Common Good Fund:

- 2012/13 £280 & £315 (2 outings including Christmas)
- 2013/14 £280 & £210 (2 outings including Christmas)
- 2014/15 £280 & £175 (2 outings including Christmas)

Recommendation

- 2.31 Bowerswell Social Group be awarded a grant of £280 towards the costs of their Christmas Lunch, for 40 people, on 11 December 2015.

Wednesday Tea Dance

- 2.32 An application has been received from Wednesday Tea Dance Group seeking a grant towards the costs of their post-Christmas Lunch, for 35 people, on 20 January 2016. Total cost are £505 and the applicant is seeking a grant of £245. The applicant has previously benefited as detailed below. It is recommended that a grant of £245 is awarded in line with the guidance (see Appendix 1 – Criteria 10). The grant will contribute to social inclusion.

- 2.33 Grants awarded to Wednesday Tea Dance Group from the Perth Common Good Fund:

- 2012/13 £263 & £154 (outing and Christmas)
- 2013/14 £280 & £189 (outing and Christmas)

Recommendation

- 2.34 Wednesday Tea Dance Group be awarded a grant of £245 towards the costs of their post-Christmas Lunch, for 35 people, on 20 January 2016.

Perth University of the Third Age (For those retired or semi-retired Perth University of the Third Age (U3A) offers opportunities to enjoy learning at leisure, to make new friends and to find new interests.)

- 2.35 An application has been received from Perth University of the Third Age seeking a grant towards the cost of printing of 2,000 copies of the “Fair Maid's House” booklet (a 48-page full colour, illustrated A5 booklet), written and designed as part of a shared learning project. The cost is £2,000 and the applicant has applied for £2,000. The applicant has never previously benefited from the fund. Proceeds from sales of the booklet will be earmarked for a future print run when the initial 2,000 copies have been used up. The booklet will be available in Fair Maid's House, Tourist Information Centres, Libraries, Museums and other appropriate outlets. It is recommended that a grant of £2,000 is awarded in line with the guidance (see Appendix 1 – Criteria 12).

Recommendation

- 2.36 Perth University of the Third Age be awarded a grant of £2,000 towards the cost of printing of 2,000 copies of the “Fair Maid's House” booklet.

People With A Mission Ministries

- 2.37 An application has been received from People With A Mission Ministries seeking a grant towards the cost of their Perth Senior Citizens 2015 Christmas Appeal. The Mission works with partners in the private, local government and voluntary sectors to provide Senior Citizens in Perth with a Christmas gift bag delivered to their homes. The aim is to provide 1,400 Xmas gift bags to senior citizens in Perth. The total cost is estimated at £13,500 and the applicant is seeking a grant of £2,000. The applicant has previously benefited as detailed below. It is recommended that a grant of £1,500 is awarded in line with the guidance (see Appendix 1 – Criteria 12).

- 2.38 Grants awarded to People With A Mission Ministries from the Perth Common Good Fund:

Breathe Easy Perthshire

- 2.40 An application has been received from Breathe Easy Perthshire seeking a grant towards the cost of their Christmas Lunch for 30 people. The total cost of the lunch is £450 and the applicant is seeking a grant of £210. The applicant has previously benefited as detailed below. It is recommended that a grant of £210 is awarded in line with the guidance (see Appendix 1 – Criteria 10). The grant will contribute to social inclusion. Grants awarded to Breathe Easy Perthshire from the Perth Common Good Fund:

- 2012/13 £210 (Christmas lunch)
- 2013/14 £210 & £200 (Outing & Christmas lunch)
- 2014/15 £210 & £200 (Outing & Christmas lunch)

Parkrun Ltd

2.42 An application has been received from Parkrun Ltd seeking a grant towards the cost of Junior Parkrun start-up costs for Perth. The costs include equipment, timekeeping devices, IT hardware & web services. Junior Parkrun will be a weekly, timed 2K running for children aged 4-14. There is already a successful 5K Parkrun event in Perth, attracting up to 200 runners per week, over 30 of which are under-15. Many more younger children are prepared to take part in a shorter event where they can run unaccompanied. Similar events in Falkirk and Stirling regular attract an average of 50 children per week. The events are planned to start in November and continue weekly. The total cost of start-up is £6,000 and the applicant is applying for £3,000. The applicant has previously benefited as detailed below. Parkrun Ltd is a company Limited by Guarantee, based in Harrogate. The event will be delivered by local volunteers. It is recommended that a grant of £3,000 is awarded in line with the guidance (see Appendix 1 – Criteria 4). The grant will contribute to social inclusion and improved health.

2.43 Grants awarded to Parkrun Ltd from the Perth Common Good Fund in:

2013/14 £3,000

Recommendation

2.44 Parkrun Limited be awarded a grant of £3,000 grant towards the cost of Junior Parkrun start-up costs for Perth.

COMMON GOOD FUNDS WITHIN PERTH AND KINROSS AREA CRITERIA

Within the boundary of the relevant common good area and if funding is available, applications will be considered from individuals either in full time education or of senior citizen status and from groups whose members qualify on the same basis or which are operating within the same boundary.

1. Christmas lighting - Firework displays up to a maximum of 50% of the total costs
2. Organisation of events/games/festivals up to a maximum of 50% of the total costs
3. Prizes at events/games/festivals
4. Acquisition of equipment - consideration on merits up to a maximum of 50%
5. Capital grants for provision/improvement of facilities - consideration on merits up to a maximum of 50% (the facilities must be available to the general public)
6. School/youth exchanges
7. School prizes
8. Voluntary work overseas
 - 6 months or more: £100 - **Perth Common Good Fund only**: up to £400 per individual
 - 1 – 5 months: £100 - **Perth Common Good Fund only**: up to £250 per individual
9. Attendance at summer schools/events
 - Less than 1 month but more than 2 weeks: £100 **Perth Common Good Fund only**: up to £150 per individual
 - One/two weeks: up to £100 per individual
10. Excursions/Parties (up to 2 per year per group)
 - Contribution of 50% towards the actual costs. Each organisation is allowed 2 applications during the course of a financial year. **Perth Common Good Fund only**: overall grant to be capped at up to £7 per individual with an overall maximum grant of up to £700.

11. Visits by and from School/Youth/Sport/Music groups

- Contributions of up to £600 for groups less than 20 individuals and up to £1,000 for groups over 20 individuals for youth groups, senior citizen or vulnerable groups for activities exceeding 1 day. **Perth Common Good Fund only and for schools:** Contribution of 50% of the costs up to a maximum of £300 for each young person who due to financial difficulties are unable to participate in an extra curriculum school activity outwith the boundaries of Perth, exceeding 1 day and organised by a school. It will be the responsibility of each school to state the purpose of the extra curriculum school activity and identify such young person and advise the Common Good Fund accordingly.

12. Any purpose where it can be demonstrated that there is a benefit to the community of the common good area

The following is not eligible:

- Assistance with further or higher education fees
- Charity based sponsored walk/cycle/canoe etc.
- Town twinning activities other than those qualifying through the age/occupation criteria
- Organisations with religious/political associations where there are restrictions on usage or availability
- Core funding of the Voluntary sector
- Assistance with rental of premises
