Civic Government (Scotland) Act 1982 – Taxi Fare Review

Report by Head of Legal Services

PURPOSE OF REPORT

The Council is required to review the scales of fares for Taxis in this area at intervals of not more that 18 months. This report outlines the findings of the most recent review and proposes that there be no increase in the fares or alteration to Tariffs.

1. BACKGROUND / MAIN ISSUES

- 1.1 In terms of Section 17 of the Civic Government (Scotland) Act 1982, the Council is required to review its scale of fares and other charges for the hire of Taxis at intervals not exceeding 18 months, whether or not any alterations are proposed. The existing scale has been in force since September 2014.
- 1.2 In accordance with the legislation a review was carried out in August 2015 and all individual operators and organisations representing, or appearing to be, representative of the operators of taxis were invited to put forward their proposals. Letters were sent to 74 Taxi Operators, 49 Private Hire Vehicle Operators with meters fitted and 2 organisations. 10 replies were received.
- 1.3 7 of those that responded wanted the fares to remain unchanged, 2 wanted the fares to be increased and 2 of those that responded suggested a change to the Tariff times.
- 1.4 As the Committee is aware, the Council operates 3 Tariffs. These provide for increasing rates from Tariff 1 to Tariff 3. Tariff 1 applies from 0630 hours until 2300 hours and for the first 880 yards of a journey with certain further provisos. Tariff 2 applies between 2300 hours and 0630 hours, again with provisos. Tariff 3 applies during the Christmas and New Year periods also with provisos. A copy of the current approved Tariffs is annexed to this report. One of those who proposed no increase suggested that normal Tariff be imposed on 24 and 31 December and the other that Tariff 2 be imposed from 1800 hours on a Friday to 0600 hours on a Monday with Tariff 3 being imposed when Christmas/New Year falls on a weekend.
- 1.5 The proposed scale of fares now requires to be advertised in the local press and interested parties require to be invited to respond within one month of the advertisement.

2. PROPOSALS

- 2.1 It is proposed that the scale of fares be advertised in the local press and that interested parties are invited to respond within one month of the advertisement. These responses would then be considered at the Licensing Committee meeting on 10 December 2015.
- 2.2 It is proposed that if no representations are received, the scale of fares and existing Tariffs remain unchanged. This would have the effect of continuing fares where there is a meter in place at the present levels until a further review is carried out in Summer 2017.

3. CONCLUSION AND RECOMMENDATION(S)

It is recommended that, if after the scale of fees are advertised in the local press, no responses are received, the existing scale of fares and Tariffs remain unchanged and a further review be carried out in Summer 2017.

If the distance exceeds 880 yards - for the first 880 yards - £3.00 and for each additional 110 yards or part thereof - 10 pence.

The charge for waiting time will be 20 pence per minute.

Tariff 2

- (a) For Hiring's between 2300 hrs and 0630 hrs excluding December 24, 25, 26, 31 and January 1 & 2.
- (b) For Hiring's begun on a Sunday except if Sunday falls on December 24, 25, 26, 31 and January 1 & 2.
- (c) For Hiring's begun on Good Friday, Easter Monday, May Day Bank Holiday, Spring Bank Holiday and August Bank Holiday.

If the initial distance does not exceed 880 yards - for the whole distance - \pounds 3.80. If the distance exceeds 880 yards - for the first 880 yards - \pounds 3.80 and for each additional 88 yards or part thereof - 10 pence.

The charge for waiting time will be 25 pence per minute.
