#### CENTENARY FIELDS INITIATIVE IN PERTH AND KINROSS

# **Report by Director (Environment)**

This report sets out the aims of the Centenary Fields initiative to commemorate World War 1. It recommends Jeanfield Park for nomination as a Centenary Field.

#### 1. BACKGROUND / MAIN ISSUES

- 1.1 Centenary Fields (CF) is a partnership programme led by Fields in Trust and the Royal British Legion to commemorate World War 1 through protecting green spaces. It was launched by HRH The Duke of Cambridge in 2014 to mark the centenary of World War 1 and will close in 2018.
- 1.2 CF aims to protect at least one site in each local authority area across the UK and the Council has been asked to nominate one or more parks or other key green space with a link to World War 1. Sites containing war memorials which are used for active recreation sport and/or play are appropriate greenspaces to nominate.
- 1.3 The main benefits of taking part in the initiative are to:
  - contribute to a UK initiative to commemorate those involved with World War 1.
  - raise awareness of both the initiative and the Council's commitment to providing for public access and recreation.
  - raise the profile of the nominated sites.
- 1.4 The initiative also aims to safeguard valued public spaces for the future however, as the area is already safeguarded as common good land, this is not an additional benefit.
- 1.5 A disadvantage to the Council is the need to obtain consent from CF in the event of any management change to the site.
- 1.6 Nominated sites are subject to an application process including a site visit by CF. If accepted, the Council is required to undertake legal processes, including signing and registering a Minute of Agreement (MoA). The MoA ensures the Council does nothing to detract from the amenity value of the site, and in the event of disposal, that the MoA is transferred to the new owner. The Council has existing MoAs for all Queen Elizabeth II (QE11) Fields. Thereafter, the Council will be required to install a commemorative plaque supplied by CF and arrange an unveiling ceremony. The site name will not change and there are no funds associated with CF status.

# Selection of eligible sites

- 1.7 Although any site within Perth and Kinross can be nominated, the landowner must complete the application form. For simplicity, and especially due to the legal undertaking required, it is recommended that the Council should nominate a site in its ownership and management.
- 1.8 In addition to the conditions covered above in relation to ownership, connection with World War 1, and its recreation function, CF specifies that eligible sites must:
  - be accessible in terms of location and affordability for the local community.
  - should have local managers who are responsible for the quality of the facilities, maintenance and development, improving participation, and financial and operational sustainability.
- 1.9 Sites which are already protected as QEII sites are not eligible. Fourteen parks and countryside sites, including those with war memorials such as the North Inch, were given QEII status following committee approval in 2011 (Environment CR 11/302 8 June 2011).
- 1.10 To identify sites eligible for CF nomination, all sites with war memorials were listed and classified in relation to their location type and associated public use (as shown within Appendix 1). War memorials within street settings, with or without floral or grass areas, and those associated with burial grounds or located within memorial gardens were discounted on the basis that these do not provide for active recreation. In addition, the Wellmeadow in Blairgowrie, although it is used as a central civic space for events, was discounted on the same basis.

# 2. PROPOSALS

- 2.1 Only two council sites are eligible and are proposed for nomination for Centenary Field status. These are:
  - The Lower Birks in Aberfeldy.
  - Jeanfield Park in Perth.
- 2.2 Jeanfield Park is located within a residential area of western Perth and has a freestanding war memorial, equipped play area, football pitch, grass and border planting, and paths providing connections to residential areas.
- 2.3 Additional information regarding this site is provided in Appendix 2.

#### 3. CONCLUSION AND RECOMMENDATION

- 3.1 It is recommended that Jeanfield Park is nominated for Centenary Field status.
- 3.2 The Head of Legal and Governance Services has been consulted on this recommendation and has confirmed that this site is common good land. There are no resource implications arising from the nomination of the site.
- 3.3 If approved, the community will be consulted regarding the proposed nomination through contact with the community council and other groups known to have an interest. Depending on community response, which is anticipated to be favourable, Jeanfield Park will be nominated.
- 3.4 The Committee is asked to approve the nomination of Jeanfield Park as a Centenary Field.

# Description of Jeanfield Park

# Jeanfield Park, Perth

<u>War memorial</u> – large free standing former water fountain located on the grass at the east end of the park marked as having been provided by the Jeanfield Residents' Association.

Ownership and management – owned and managed by the Council as a park with neighbourhood equipped play area (NEAP), football pitch and a path connects Jeanfield Road and Hawarden Terrace with Rannoch Road providing a short cut. The play area is to be refurbished in 2015.

<u>Public knowledge and use of site</u> – A local park known of and used principally by local residents.

<u>Community interest</u> – There is a changing facility in poor condition owned by the football club (Tay Thistle AFC).
