There was submitted a report by the Depute Director (Environment) (15/205) seeking approval for the sale of the former Housing Repairs Depot at Inveralmond Road, Perth to The Partners and Trustees of Raad's Garage following offers received on 31 March 2015.

**Resolved**

- (i) The sale of the former Housing Repairs Depot at Inveralmond Road, Perth to The Partners and Trustees of Raad's Garage or their nominees, on the basis of the terms contained in Report 15/205 and otherwise on terms and conditions to the satisfaction of the Head of Planning and Development and the Head of Legal Services, be approved.
- (ii) In the event that the offer from The Partners and Trustees of Raad's Garage fails to deliver a concluded bargain, the offer from the second highest bidder, be pursued on the terms outlined in Report 15/205 and otherwise on terms to the satisfaction of the Head of Planning and Development and the Head of Legal Services, be approved.
- (iii) In the event that the offer from the second highest bidder fails to deliver a concluded bargain, the offer from the third highest bidder be pursued, on the terms outlined in Report 15/205 and otherwise on terms to the satisfaction of the Head of Planning and Development and the Head of Legal Services, be approved.
