### 238. WELCOME

**242. NORTH INCH GOLF COURSE – BUSINESS PLAN**

There was submitted a report by the Director (Environment) (16/141), (1) providing the Committee with an update on the North Inch Golf Course and (2) recommending the implementation of a 6 year business plan for the Course.

**Resolved:**

- (i) The North Inch Golf Course business plan, as detailed in Appendix 1 of Report 16/141, be approved.
- (ii) The Director (Environment) be instructed to bring an annual report on the North Inch Golf Course to the Environment Committee in September each year.

**243. BEREAVEMENT SERVICES – FUTURE CEMETERY PROVISION STRATEGY**

There was submitted a report by the Director (Environment) (16/142), (1) considering the strategy for future burial provision within the Perth and Kinross area, primarily to address the areas where there is a supply of ten years or less new lair space, and (2) proposing an approach to cemetery provision which will continue to serve both urban and rural communities, offering accessible, sustainable and appropriate resting places.

**Resolved:**

- (i) The Future Cemetery Provision Strategy, as detailed in Section 2 of Report 16/142, be approved, subject to capital funding being available to deliver the strategy.
- (ii) The Director (Environment) be requested to continue to explore the potential for re-use of unused lairs in line with current policy and ensure this is reviewed once the new Burial and Cremation (Scotland) Bill 2016 is enacted.
