## Environmental Assessment (Scotland) Act 2005 Screening Determination Perth & Kinross Council Local Development Plan: Delivering Zero Waste Supplementary Guidance

This statement sets out the Council's determination under Section 8 (1) of the Environmental Assessment (Scotland) Act 2005 as to whether or not a Strategic Environmental Assessment (SEA) is required for the above Supplementary Guidance.

### SEA screening procedure

The screening procedure involved consulting the following Consultation Authorities on whether the Supplementary Guidance is likely to have significant environmental effects:

- Historic Environment Scotland;
- Scottish Environmental Protection Agency; and
- Scottish Natural Heritage

In addition, responsible authorities are required to take into account the criteria set out in Schedule 2 of the Act when determining whether or not the Supplementary Guidance is likely to have significant environmental effects.

In this instance, the Council wrote to the Consultation Authorities on 23 March 2016 and the responses are summarised as follows:

The Council has also considered the plan against the criteria set out in Schedule 2 of the Act, an analysis of which is attached.

# Reasons for Determination

Having consulted the three consultation authorities, and having considered the criteria set out in the Act, the Council considers that the Local Development Plan: Delivering Zero Waste Supplementary Guidance is unlikely to have significant environmental effects.

Context of the Plan:	This supplementary guidance will be prepared in the context of the Perth & Kinross Local Development Plan (LDP), adopted 2014. The LDP contains a policy relating to waste management infrastructure and It is intended that the supplementary guidance will provide support, further information and detail in respect of this policy. This supplementary guidance will also be prepared in the context of TAYplan Strategic Development Plan (SDP), approved 2012; and Scottish Planning Policy (SPP), published 2014 – especially paragraphs 175-192. The supplementary guidance is not intended to have influence on other plans					
	and policies because it will guide the reader to other existing sources of information on the topic. It will not introduce new material of its own. Once adopted, it will be a material consideration in the determination of planning applications in the LDP area.					
Description of the Plan:	It is intended that the supplementary guidance will not introduce new material nor policy/locational criteria for waste management infrastructure. Instead, it will offer a consolidating guide to existing policy and guidance relating to waste management infrastructure. Its focus will be on promoting easy access to existing information. Its spatial scope is the same as the Perth and Kinross LDP (it will not apply to those areas of Perth and Kinross that are part of National Parks). Its temporal scope is the same as the LDP because it will be adopted as supplementary guidance to that plan therefore it will fall when that plan is replaced.					
What are the key components of the plan?	The Supplementary Guidance will refer to National policy and advice, including from Scottish Government and SEPA; SDP policy on waste management; and Perth and Kinross Council LDP policy and waste management advice.					
	Its focus will be on guiding the reader to existing material on subjects such as the waste hierarchy, capacities of existing waste management facilities, making better use of waste as a resource.					
Have any of the components of the plan been considered in previous SEA work?	The LDP policy under which this supplementary guidance is to be prepared has been considered as part of the SEA of the LDP, which was completed in 2014. This plan contains Policy EP9 that took account of the need to retain existing waste management infrastructure; and to incorporate waste management infrastructure into new projects, subject to criteria set out in the policy.
