Concession	Not-for-profit community benefit groups such as Adult Education associations, MP/MSP/MEP, religious activities, Community Planning partners, local voluntary and charitable organisations. Youth Groups where instructor/club leader does not retain income.
Standard	All groups that do not fall under the Concession criteria; groups where instructor retains income.
Junior	Under 18 activities.
No Charge	All Council Services; Parent Councils/Elections; Kids Club (non-profit-making).
Commercial	Individuals or commercial groups/organisations who are profit-making - price on request.
Surcharges	Surcharges will be charged on a full cost recovery basis for lets finishing outwith normal operating hours or advertised locations/evenings and for any additional cleaning required.
VAT on Sporting and Recreational Lets	VAT is chargeable at the current rate on sporting/physical recreation lets as per the conditions set out in Section 5 of HMRC Notice 742 Land and Property.
