- Partners plan and deliver services in a more strategic and collaborative way.
- People have better access to the services they require, including welfare, health and wellbeing, housing and employability.
- Effective interventions are delivered to prevent and reduce the risk of further offending.
- Life chances are improved through needs, including health, financial inclusion, housing and safety being addressed.
- People develop positive relationships and more opportunities to participate and contribute through education, employment and leisure activities.
- Individual's resilience and capacity for change and self- management are enhanced.
