All public areas of the brewery are disabled accessible. The entirety is on one level with no steps, ramps or changes in gradient. This is advertised in our social media as being accessible to all. There is one area in the upstairs primarily used as an office for our brewery that may be used for conference facilities etc, however in the instance where the venue needs to be accessible other areas can be used for the event. All day to day license activities all take place on the ground floor which is entirely accessible

## Facilities available

The main toilet is disabled friendly and gender neutral. It is a large space with bars either side to aid use. The sink is at an appropriate height also.

There are accessible tables for use when consuming food or drink.

There is no requirement for lifts as the entirety of the property is on one flat level this includes the threshold from the car park into the property. The unit also has large roller doors that can be opened for enhanced accessibility.

There is parking directly outside the property and we are happy to allow users to bring cars directly to the door if it would be of additional help.

All of this information can be gleaned from visiting or calling ahead to the property.

All staff are trained appropriately. Including one with a Teaching Degree and significant experience in a Deaf Education School.
