STEP 2 – CONTEXT AND DESCRIPTION OF THE PLAN

Context of the Plan:

The Green Infrastructure Supplementary Guidance has been prepared to support Policy 40 of the Proposed Local Development Plan. Its purpose is to provide more detailed guidance on how the Policy should be implemented.

Description of the Plan:

The Supplementary Guidance covers the geographic area of Perth and Kinross excluding those parts which lie within the Loch Lomond & the Trossachs and Cairngorms National Parks. Its aim is to protect and enhance existing green infrastructure and create new linkages for the benefit of people and the environment. Strategic maps identify existing green infrastructure at a landscape level as well as opportunities for new development to deliver improvements to the network. The guidance outlines the benefits of incorporating green infrastructure into new development and gives more detailed guidance on how this may be achieved through the design of proposals and the planning process.

The guidance will be reviewed with the preparation of each new Local Development Plan unless a need is identified for earlier review e.g. in light of significant changes in Scottish Planning Policy or the Strategic Development Plan.

What are the key components of the plan?

The Guidance is made up of two main components:

- 1. Identifying existing green infrastructure and opportunities for improvements (methodology & spatial representation)
- 2. Delivering green infrastructure in new developments

Have any of the components of the plan been considered in previous SEA work?

The Proposed Local Development Plan and Strategic Development Plan (TAYplan) which provide context for the guidance have undergone a Strategic Environmental Assessment. The SEA of the PLDP concluded that, the Policy 40 has significant positive impact on the quality of water, air and soil. It provides mitigation against the effects of climate change and enhances the townscape and setting of settlements and the historic environment. Its open space and landscape function enhances quality of life and provides an opportunity for recreation.
