The Royal Hotel is a 17th century coaching inn set in the corner of the main square of the riverside village of Comrie. All our public rooms are on the ground floor; including our restaurants, bars and toilets (two of which offer disabled facilities), and are fully accessible by wheelchair and we endeavour to meet all the needs of guests with limited mobility and disabilities. All entrances and doors to public areas have wide, wheelchair accessible doors. Due to the age of the building there are a number of period features which regrettably have made the addition of a lift impossible. Unfortunately therefore we are unable to offer residential rooms to people with limited mobility as all our letting bedrooms are situated on upper levels, and we have no ground floor rooms.

Entrance to the Building - From the Front:

The main hotel entrance is located at the front of the building on the main square of Comrie, set back just off the A85 Perth to Oban road. Vehicles can stop here to drop off passengers and baggage. The entrance is well lit. The main entrance is all one level, no steps. Car parking is available on the square, and to the side of the Hotel Building, with access up the side lane to our Hotel car park at the back of the Hotel. Entrance to the Bistro Bar can be made via wheelchair through the garden entrance at the back of the building.

Entrance to the Building - From the Back:


The main car park is at the back of the hotel and is a well lit gravelled area.

Directly from the car park you can access the Bistro Bar back entrance. Via the Hotel Garden (gravel and lawn - not easy wheelchair access) you can enter the back of the hotel on the ground floor.
